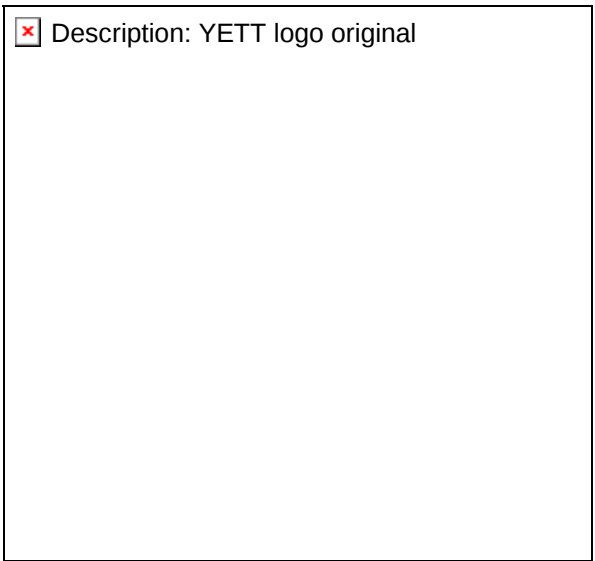

Criteria for Selection

Applicants will be selected through an open, merit based competition. All applications will be judged by a panel of renowned entrepreneurs based on the following criteria;

1. Originality- innovativeness, demonstrate creativity and originality of idea
2. Social impact- the socio- economic impacts of the proposed innovation, and how it addresses development challenges faced by a community with particular attention to young women concerns.
3. A project idea that contributes to youth employment and poverty reduction
4. Unique, low cost and high returns
5. Targets vulnerable groups
6. Nature of project especially in terms of its technical feasibility and its market
7. Quality of business plan and financial feasibility and its market
8. Compliance with national laws and regulations

YETT Youth Entrepreneurship Challenge Timelines

- 1 October 2012: Call for Entries
- 21 October 2012: Closing Date for Application
- 31 October 2012: Announcement of Shortlisted Applicants selected by panel of judges
- Round one 12 to 15 November 2012: Shortlisted applicants attend the Global Entrepreneurship Week
- Round two announcements of the shortlisted twenty for oral presentations before a panel of judges.
- Round three 15 November 2012: Final winners announced and awarded

Closing Date

The closing date for the 2012 YETT Youth Entrepreneurship Challenge is Saturday the 21th of October 2012. Please note that late or incomplete applications will not be considered. Shortlisted participants will be notified on the 31th of October 2012.
