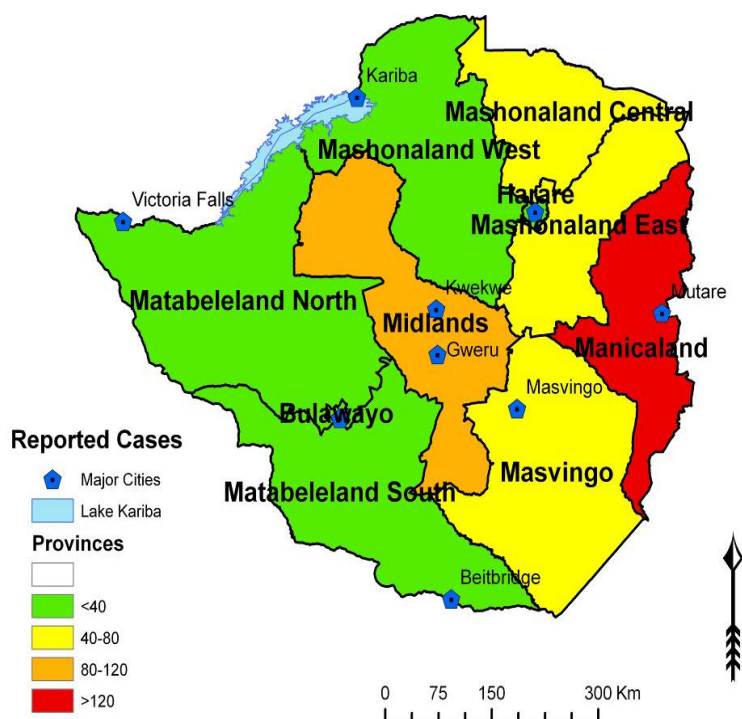


## ZPP Monthly Monitor

**August 2012 Provincial Violations Map**



### BACKGROUND & FORMATION

The Zimbabwe Peace Project (ZPP) was conceived shortly after 2000 by a group of Churches and NGOs working or interested in human rights and peace-building initiatives, and was to become a vehicle for civic interventions in a time of political crisis. In particular ZPP sought to monitor and document incidents of human rights violations and politically motivated breaches of the peace e.g. violence.

Today, ZPP's co-operating member organizations include, Zimbabwe Council of Churches (ZCC), Catholic Commission for Justice & Peace in Zimbabwe (CCJPZ), Evangelical fellowship of Zimbabwe (EFZ) Zimbabwe Election Support Network (ZESN), Counselling Services Unit (CSU), Zimbabwe Civic Education Trust (ZIMCET), Zimbabwe Lawyers for Human Rights (ZLHR), Zimbabwe Human Rights Association (ZIMRIGHTS), Civic Education Network Trust (CIVNET), Women's Trust and the Habakkuk Trust.

## **METHODOLOGY**

This report is based on reports from ZPP long-term community based human rights monitors who observe, monitor and record cases of human rights violations in the constituencies they reside. ZPP deploys a total of 420 community-based primary peace monitors (two per each of the 210 electoral constituencies of Zimbabwe). These community-based monitors reside in the constituencies they monitor. They compile reports that are handed over to ZPP provincial coordinators who manage the different ZPP offices in the ten administrative provinces of Zimbabwe. Upon receipt and verifications of the reports from the monitors, the provincial coordinators compile provincial monthly monitoring reports, which are then consolidated at national office into the ZPP monthly monitoring reports published in retrospect.

## **EXECUTIVE SUMMARY**

The political environment in Zimbabwe deteriorated considerably in August due to the impasse in the Constitution-making exercise. The month of August witnessed a significant rise in incidents of politically motivated human rights violations as a direct result of the political impasse.

There were 462 cases recorded during the month under review up from the 375 incidents recorded during the month of July.

The COPAC led process stalled: raising political tension and deepening polarization as the partners in the Global Political Agreement took hardened and opposing positions on the COPAC draft constitution which ironically- was co-authored by their representatives in the Constitutional Parliamentary select committee (COPAC).

ZANU-PF rejected the COPAC draft and insisted on forcing its own amendments into the draft constitution. The party launched a vilification campaign against the draft labelling it “a gay instrument of neo-colonialism”.

Meanwhile-its partners in the coalition government- the two MDC formations have endorsed the draft and praised it as a progressive document- setting the scene for a constitutional referendum that might lead to a bruising political contest.

The national census program was turned into a fiasco as soldiers and other members of state security agencies invaded the enumerator training centres across the country seeking to impose themselves on the program and displace teachers alleging that they were aligned to the two MDC formations who wanted to use the exercise as a platform to campaign for their parties.

Reports from across the country indicate that their motive was not political but material as the hefty allowance set aside for enumerators was the actual incentive for them to seek to muscle in on the program.

An analysis of the violations trends over the past five years shows that the month of August has had fewer cases of human right violations since 2008 where 964 cases were recorded two months after the ill-fated June 27 Presidential run-off.

The violations continued on a downward trend in 2009 where 527 cases were recorded only to increase in the year 2010 to 848 reported cases while 720 incidents were witnessed in August 2011.

## Major Highlights for the month of August 2012

- ZANU-PF aligned militias organized under the banner of a shadowy political grouping that calls itself “*Simudza Makoni Youth Group*”, invaded Rusape Country Club looting property and other stocks including beer. The group led by one Kudzai Chipanga, told the chairperson of Rusape Country Club that they had been sent by the patron of the youth group Honourable Didymus Mutasa to take over the club. They eventually took over the country club through the use of fear, threats and terror.

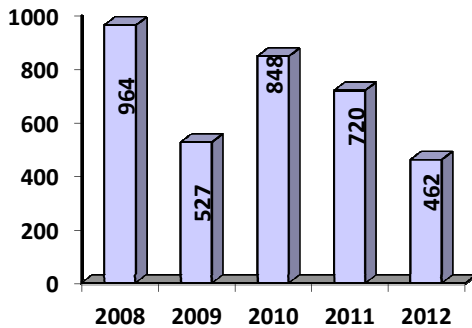


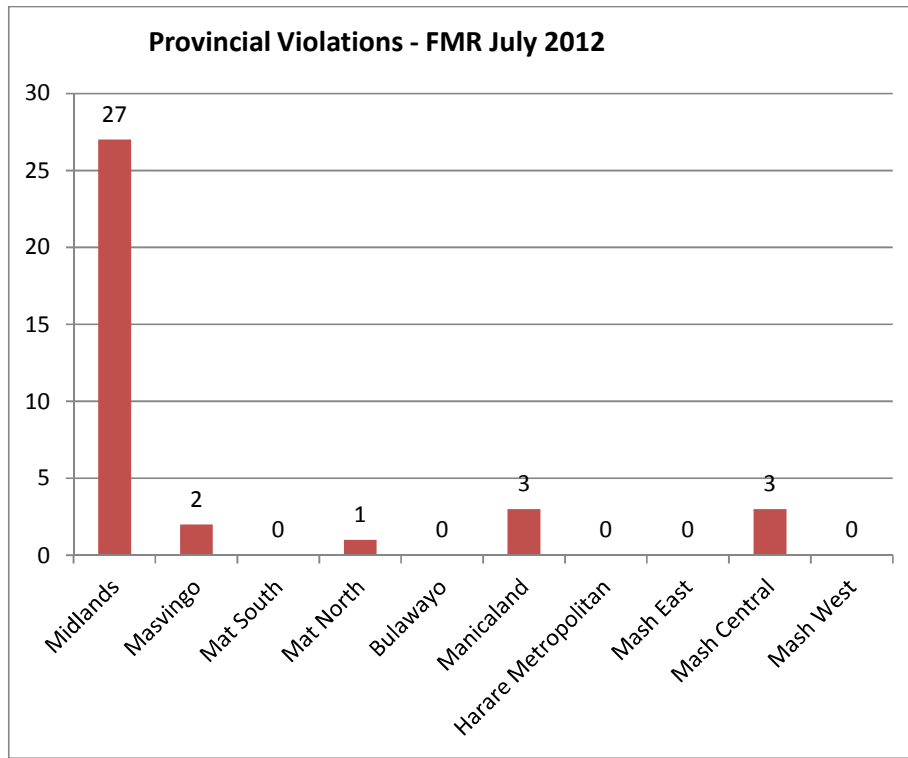
Figure 1: Trends of PMV for Aug 2008 – Aug 2012

➤ From Mazowe Central constituency in Mashonaland Central, a popular Medical Doctor Paul Thistle based at Howard Mission Hospital was forcibly transferred in questionable circumstances that are suspected to be informed by political imperatives. The doctor was very popular with the local villagers for whom he went out of his way to

assist.

- Intra-party strife within the MDC-T led to skirmishes between the supporters of sitting Gutu North MP- Edmore Maramwidze and those of Dr. Tichinani Mavetera who is campaigning to depose him as the MDC-T candidate in the next elections.
- There was a memorial service on 11/8/12 for the late Mushure Jongwe who was a top MDC-N activist in Chikomba Central, Unyetu village. Distribution of the MDC-T Newsletters was the bone of contention that sparked the brawl and skirmishes between the party members. Admire Chakwizira was injured in the process. It was a case of a kettle and a pot calling each other black. MDC-T accused MDC-N of tearing their Newsletters whilst the latter accused MDC-T of forcing them to read their party materials. High profile MDC-T officials attended the function. There was Piniel Denga(MP-Mbare), Moses Jiri(MP-Chikomba Central), goodwill Chimbaira (National Chair-MDC-M) and Headman Ranga of Runyeta village.
- In Highfield west constituency- Arnold Musingwini of Zanu-PF was allegedly assaulted by Rocky Makusha- the driver of the local Member of Parliament Simon Hove on 30 August 2012 at Gazaland Shopping Centre after he was seen pulling down MDC-T posters. MP Hove confirmed the incident saying that the matter was reported at Machipisa Police Station.
- Zimbabwe Election Support Network (ZESN) failed to conduct a public meeting at Chirasha Township in Shamva North constituency after no one turned up for the meeting. The ZPP is reliably informed that ZANU-PF supporters and the youths militia threatened residents with death or displacement if they came anywhere near the venue of the workshop. ZESN confirmed this incident.
- On a positive note- the Joint Monitoring and Implementation Committee (JOMIC) has increased its presence and visibility in the province especially in volatile Highfield suburb where its vehicles are always on patrol. The increased visibility of the body has led to a freer atmosphere.

- Harare Province also witnessed clashes between touts, ranks marshals and commuter omnibus operators over high ranking charges that were linked to the Chipangano gang (Mandimbandimba) which is allegedly aligned to Zanu PF. The ZPP could not immediately establish all the incidents related to this. According to media reports, there are over 6000 commuter omnibuses in Harare and the tout were now demanding US\$2 per trip. The issue became more of scam that was enriching the wrong people as the Harare City Council now claims it could have lost millions of dollars in revenue.



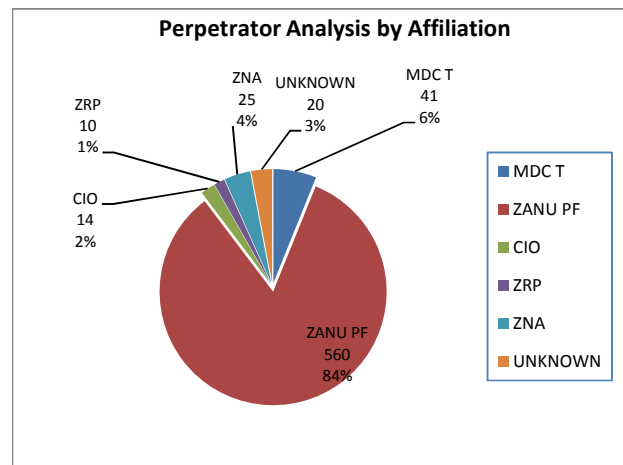
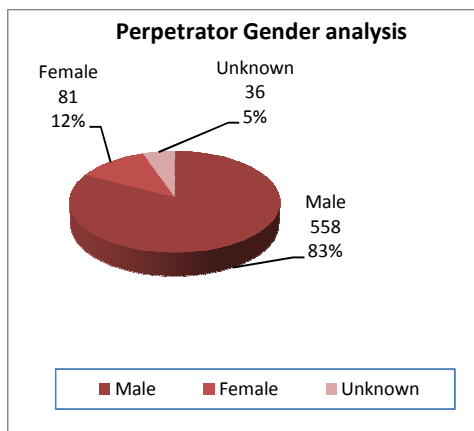
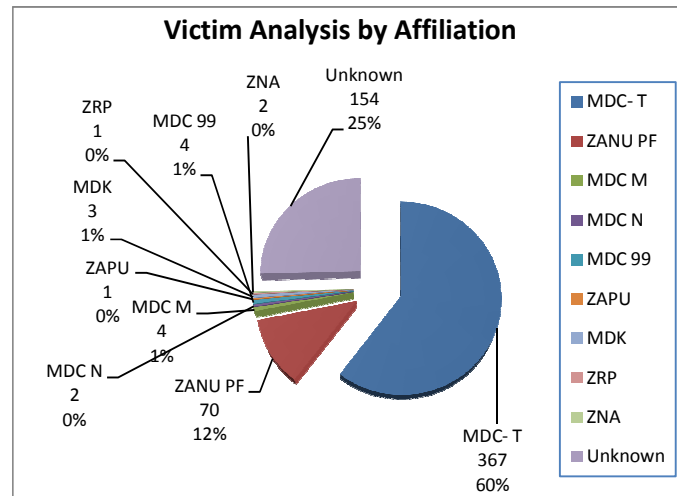
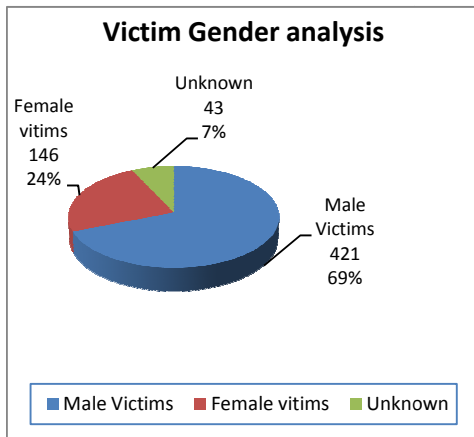
