Constitution Breakthrough? What's in For US?

If not, was it semiology? In the sense that the people responsible for the sitting arrangement had wanted to send a babwean politics. Was it not that Mugabe/Tsvangirai was likely to dominate while Ncube and Mutambara would battle it out. Then if so what were we supposed to make of it? Realize that there will be many small and cascading struggles. He then unfolded the newspaper and the story made me jump in happiness. At least we were getting direction. But Matigari asked me if it made sense that the four men had decided to hold the country at ransom. I asked what ransom? The political leaders were solving a political logjam. Then Matigari said; "Politicians create problems at night and wake up pretending to proffer solutions." Should we have gone this far? He asked. How far? "I mean to these guys, don't you see that this is a clear sign that we had no big voice in the document" said Matigari. I began to see the light. He went on to tell me that this was a clear sign that the people had been taken for granted. It was a money making venture by the politicians. They used cheap tricks to make the people keep their eyes off the ball and the result was this. He equally had no kind words for Simba Makoni and his MKD. He asked where they were when the elites were doing all tricks. It is a clear sign that they are not vigilant, said Matigari. He said: "At least this will not affect my life in the short term but in the long run, we admit we have been cheated big time."

Cautious About the Breakthrough

We are very cautious in accepting last week's agreement between Zanu PF, MDC-T and MDC-M/N on the way forward on the new constitution. Our caution is not a product of skepticism or pessimism or cynicism or a propensity for opposing for opposition's sake. A critical review of the ragged and meandering path that has been carved on the political canvas is a cause for concern. If anything, the whole process lost its elixir and the desultory and clumsy markings left wherever the giant foot of COPAC stepped is a wailing testimony of the voices which have been silenced along the long and ragged path. A few voices survived beyond the classrooms, open spaces, under trees and conference rooms where views were solicited. These views, narrowed to elite talking points were

collected and let to rot. Since the people had not been told what their role was, there was no way they would demand further input. Their views were packed and shipped to a desert island where they could not access. The elites, satisfied that they had pulled wool over the eyes of the masses, then withdrew from the public eye. They knew that no one would challenge them as they had not empowered anyone but COPAC. The retreats, both metaphorically and in reality were met with silence, save for feeble mentions in the media. which did not stop the elite. There were elite fights, and since they had ignored the people's voices, or is it they had imposed their own views, systematically marginalizing the voices of the many.
